REMINDER THAT THE ICT SECTOR COUNCIL (ICT COUNCIL) ANNUAL FEES 2022/23 ARE DUE ON OR BEFORE 01 DECEMBER 2023

Dear Sir/Madam,

The 2023 ICT Council Annual Contribution Fees for period 1st March 2022 to 28 April 2023 are due on or before 01 December 2023. ICT Sector Measured Entities who are measured under the 2016 Amended ICT Sector Code are required to submit proof of annual contributions. SANAS Verification Agencies are now required to verify that Measured Entities have submitted B-BBEE certificates and reports to specific sector councils.

Contribution Fees are a mechanism to funding the operations of Sector Charter Councils as outlined in the directive issued by the Minister of Trade Industry and Competition in May 2015. ICT contribution fees are calculated based on the annual turnover as indicated in the Measured Entity Type in the B-BBEE Verification Certificate and or the B-BBEE Sworn Affidavit issued under the 2016 Amended ICT Sector Code. Fees paid to the Council cannot be claimed towards B-BBEE points under the 2016 Amended ICT Sector Code.

ICT GE	ICT Sector Generic Entity whose turnover is more than R50M	0,015% of the Net Profit After Taxes (NPAT) or R 2,500.00 or whichever is greater
ICT QSE	ICT Sector QSE Entity whose turnover is more than >R10M and < R50m	R 1,250.00
ICT EME	EME Entity whose turnover is less than <R10M:	R 650.00
